AMENDMENT TO DECLARATION OF
COVENANTS, CONDITIONS AND RESTRICTIONS
OF MILLSITE VILLAGE

The undersigned, owners of certain real property situated in Yavapai County, State of Arizona, to-wit:

Lots 18, 20, 21 and 28, MILLSITE VILLAGE according to a plat thereof recorded in the office of the Yavapai County Recorder in Book 26 of Maps, at page 67 (the "Property");

hereby request and declare that the said property shall be held, sold and conveyed subject to the Declaration of Covenants, Conditions and Restrictions of MILLSITE VILLAGE as recorded October 14, 1988 in book 2088 commencing at Page 219 and as amended November 2, 1988 in book 2093 commencing at Page 702 thereof, with the Yavapai County Recorder's office;

WHEREAS, a certain Declaration of Covenants, Conditions and Restrictions dated October 14, 1988 (the "Declaration") exists for other MILLSITE VILLAGE properties and was duly recorded on October 14, 1988, in book 2088 commencing at Page 219 thereof, with the Yavapai County Recorder's Office;

WHEREAS, as a part of said Declaration, the right to amend is granted to the Owners of not less than two-thirds (2/3) of the Lots:

WHEREAS, at a meeting of the Board of Directors of MILLSITE VILLAGE PROPERTY OWNERS ASSOCIATION, (the "ASSOCIATION") held March 31, 1996 the Board of Directors, representing more than two-thirds of the Lot Owners, unanimously approved the request of the owners of lots 18,20,21 and 28 to join the ASSOCIATION.

WHEREAS, the undersigned are desirous of amending the Declaration.

NOW THEREFORE, the Declaration of Covenants, Conditions and Restrictions of Millsite village recorded on October 14, 1988, in Book 2088 commencing at page 219 thereof with the Yavapai County Recorder's office and as amended November 2, 1988 in book 2093 commencing at page 702, shall be amended as follows:

1. Add lots 18,20,21 and 28 to the ASSOCIATION.






